MEMORANDUM FOR ALL TC 8-800 MEDIC TABLES I-VIII

SUBJECT: Welcome Letter, Fort Stewart Medic Simulation Training Center TC 8-800
MEDIC TABLES I-VIII

1. Congratulations, you are receiving this letter because you have been accepted into the Fort Stewart Medical Simulation Training Center (MSTC), TC 8-800 MEDIC Tables I-VIII. This course is a 9-day course designed to ensure the utmost proficiency and preparedness, demonstrating your medical skills. This course includes instruction in casualty care at the point of injury, triage, primary and secondary survey of combat casualties, combat airway management, combat extremity trauma, combat chest trauma, and combat extremity trauma. Practical exercises are conducted on high fidelity simulation manikins. Students will conduct scenarios in both clinical environments and high fidelity simulated combat environments. All scenarios and exercises will refresh critical knowledge and skills and provide continuing education credits and skills validation for the NREMT.

2. ATTENDANCE POLICY:

Due to the intensive and fast-paced nature of the course, full attendance is mandatory. Students are required to attend all scheduled sessions each day for the duration of the course. Missing any portion of the course, without prior approval, will result in immediate dis-enrollment. Exceptions will be considered only in emergency cases on a case-by-case basis.

3. REPORT:

- a. REPORT DATE is a travel day prior to Start Date.
- b. On start date, report to the Fort Stewart MSTC, Bldg. 3002, 1773 Champagne Ave (formerly W 15th Street), Fort Stewart, GA 31315 no later than 0830.
- c. Upon report, the Fort Stewart MSTC is your place of duty. Due to the challenging nature of the coursework, students are recommended to maintain focus on the assigned work and additional tasks related to TC 8-800 MEDIC Tables I-VIII.

5. DEFICIENCIES:

Students have 24 hours from the beginning of Day 1 to provide all missing documentation requirements from the required documents. Students who fail to meet this deadline will be dis-enrolled and dismissed from the course.

6. TRAVEL:

- a. Lodging: Government lodging is not provided for MEDIC Table I-VIII students. All temporary duty (TDY) students are required to book lodging through the Defense Travel System (DTS) for the duration of their stay during MEDIC Table I-VIII at Fort Stewart, GA. Students should attempt to attain lodging at the FT. Stewart IHG on Main Post, 304 Coe Avenue 4951, FT. Stewart, GA 31315. If Lodging is not available at the On-Post IHG, Students/Soldiers are authorized to lodge Off-Post at the full PER DIEM Rate.
- b. Transportation: The Ft. Stewart MSTC is located four miles from the Ft. Stewart IHG. Shuttle Transportation is not available. Students are required to have a Rental Car Authorized or Personally Owned Vehicle (POV) for the duration of the course. The MSTC recommends reimbursement of mileage incurred by students while at the course. All students flying to Savannah airport should schedule your return flights NET 1500 the Day of graduation.
- c. Meals: Meals are not provided and will be at the Soldier's own expense.
- d. DTS: Fort Stewart MSTC is not an Institutional Training-Temporary Duty (IT-TDY) Schoolhouse that Funds Soldier's Travel. The Soldier's Major Command or Organization G-8 (Training budget) Funds the Soldier Travel and provide their own IT-TDY Lines of Accounting.
- e. Fort Stewart MSTC is not manned during the weekend and closes in 1700 during the duty week. Fort Stewart MSTC points of contact:

- f. Packing list: The ACU uniform is worn throughout the duration of MEDIC Tables I-VIII. Army Physical Fitness Uniform (APFU) will be required on day 5 during musculoskeletal and IV training. During skills validation you will be required to wear IOTV, ACH, Gloves, hearing protection, **headlamp** and eye protection. Knee pads are encouraged but not required. *Headlamps will be vital to you passing your trauma validation.*

7. You can expect to receive a total of 48 re-certification CEUs toward your NREMT proficiency, with areas of emphasis including trauma, airway management, IV access and medication administration, medical emergencies, triage and evacuation, force health protection, and OB/Peds/Gyn. This training also includes annual skills validation.

8. Again, congratulations on your selection. We look forward to your participation in this very challenging course. Your experience in the course and critical feedback is invaluable to our effort in delivering the best outcome-based education for the medical enterprise.
