MEMORANDUM FOR All Sports Outdoor Facility Users on Fort Stewart/ Hunter Army Airfield (FS/HAAF)

SUBJECT: U.S. Army Garrison Fort Stewart/Hunter Army Airfield (FS/HAAF) Policy Memorandum #12, Directorate of Family and Morale, Welfare and Recreation (DFMWR) Sports Outdoor Facilities Policy

1. REFERENCE. Army Regulation 215-1 (Military Morale, Welfare, and Recreation Programs and Nonappropriated Fund (NAF) Instrumentalities), 24 September 2010.
2. PURPOSE. To provide guidance and establish a policy for the FS/HAAF DFMWR Sports, Outdoor Facilities and Complexes.
3. APPLICABILITY. This policy applies to all Servicemembers, Family Members, Retirees, DA Civilians, contractors, and other personnel for the use of these facilities on FS/HAAF. Policies cover Bennett Sports Complex (FS, Quick Track (FS), Annex (FS) and Squires Sports Complex (HAAF) unless stated otherwise.
4. POLICY.
 - a. Military training is prohibited on all fields and tracks.
 - b. Physical Training (PT) is authorized on all fields except the FS Bennett Sports Complex and HAAF Squires Sports Complex.
 - c. Military and civilian vehicles are prohibited on all athletic fields or in common areas adjacent to the athletic field.
 - d. Activities causing excessive wear, such as rugby and tackle football are not allowed at these fields. Exception to this policy is a DFMWR sponsored event.
 - e. Fields prepared for DFMWR sponsored events will be off limits the day of the event after 1200hrs.
 - f. Use of outdoor athletic facilities must be requested in writing and approved by the Sports Director.
 - g. Scheduled groups are required to clean the complex area, to include the latrines at the completion of their event.

h. Animals are prohibited on these fields/tracks. Exception to this policy are service animals.

i. Loud music and music containing inappropriate language is prohibited.

j. Abusive and/or inappropriate language from patrons is prohibited. Patrons not abiding by the rules will be escorted from the complex.

k. Footwear containing a hard sole or spike over 1/3" is prohibited.

l. Hitting of any type ball into the fences is prohibited.

m. Bleachers and/or DFMWR placed items will not be moved unless approved by Sports Director.

n. DFMWR activities take priority over all other activities.

o. Heavy equipment, to include mowers will not be allowed on the Quick Track surface.

p. Strollers are allowed on Quick Track but restricted to the outside lane.

q. Skateboards, motorized vehicles, and bicycles are prohibited on Quick Track.

r. Soft drinks, food, and gum are prohibited on Quick Track.

5. Failure to abide by this Policy may result in the immediate loss of privileges. Any decision concerning the outdoor sports facilities not contained in this Policy Memorandum will be left to the discretion of the Sports Director.

6. EXPIRATION. This Policy Memorandum will remain in effect until superseded or rescinded.
