SUBJECT: Review for the Permanent Exception to Policy at Fort Stewart, GA to Store Category II weapons in Category III Rated Storage Facility

1. Reference AR 190-11, 2-4c (Physical Security of Arms, Ammunition, and Explosive).
2. In January 2017, Office of the Provost Marshal General (OPMG) approved the subject request for permanent exception to Army Regulation (AR) 190-11, Physical Security of Arms, Ammunition and Explosives (AA&E) arms room construction standards.
3. The Directorate of Emergency Services has reviewed and updated the 2017 Permanent Exception to Policy at Fort Stewart, GA to Store Category II weapons in Category III Rated Storage Facility.
4. Numerous arms rooms on Fort Stewart and Hunter Army Airfield do not meet the structural standards as outlined in Appendix G of AR 190-11, para G-2 (2) b,c,d, and e as evidenced by the assigned DA Form 4604, Security Construction Statement. To meet regulatory requirements in AR 190-11, the facilities will have to be rebuilt or reinforced which is not feasible and would prove to be cost prohibitive.
5. All listed arms room facilities exceed the construction criteria for Category III weapons storage and are equipped with either high security padlocks or built-in, three position changeable combination locks; issue windows are welded to a steel frame that is securely attached to the wall with fastenings inaccessible from the exterior of the arms storage facility/ As a compensatory measure, the locks on the exterior doors are checked every four hours by Staff Duty or Guard Duty personnel after duty hours.
6. See Enclosure 1 for the listing of arms rooms that have been identified as not meeting the security construction standards (DA Form 4604) for Category II weapon storage. The overall site vulnerability is not greater than the physical security and compensatory measures currently being implemented at all of the listed arms rooms.
