AGENT CHECKLIST

- Original AE Form 400-4B (Signed by Registrar & Physician) ← **CHILD BORN IN U.S FACILITY HOSPITAL** OR
- Original GEBURTENREGISTER (German Birth Certificate) ← **CHILD BORN IN A GERMAN HOSPITAL** (Birth prior to Feb 2009, form E-2)
- Both parents military ID cards, **BOTH PARENTS AND CHILD MUST BE PRESENT** (or accounted for- see below if parent will be absent more than 30 days from Germany)
- Form DS 2029: PRINTED Application for Consular Report of Birth Abroad of a U.S. citizen (**Do not sign application**) or completed eCRBA process including payment
- DS-11: online application for a U.S Passport with bar code in the upper left corner from (www.travel.state.gov) (**Do not sign the application**)
- One (1) passport photo (2X2 INCHES) (Military and Civilian sponsored obtain Photo in Bldg 2948 2nd floor. Contractors/NAF must provide their own photos)
- Proof of Physical Presence in the US: ORB/ERB/SERF/SRB, DD-214, HS/College Transcripts, Wage Statements; Secondary Proofs: utility/credit card bills, Airline ticket stubs, Former/current Passport with entry/exit stamps.
- U.S. PASSPORTS OF PARENTS (Original must be seen by agent and submitted with application)
- OR U.S. Birth Certificate IF NO U.S. PASSPORT EXISTS (Original must be seen by agent and submitted with application)
- Country National Identification for Non U.S. parent (Non U.S. Passport must also be submitted with application!)
- Naturalization or Citizenship Certificate if a parent has EVER been issued one of these.
- Parent's original marriage certificate (Any marriage or union)
- Parent's original final divorce decree or annulment from all previous marriages, if applicable (**Copies are NOT acceptable**)
- For parents not married to each other, please bring a DS-5507 and The German Vaterschaftsanerkennung (paternity document) and The German Sorgerechterklärung specifying sole or joint custody.

Name discrepancy affidavit: parent must have 3 forms of photo ID dating back 5 years with correct name

FOR USE UNDER SPECIAL CIRCUMSTANCES WHEN ONE OF THE PARENTS IS UNABLE TO BE PRESENT

The following may be used ONLY if a parent is out of Germany for more than 30 days

- DS -3053 Statement of consent: Issuance of U.S passport to minor under age of 16. Must have the original notary stamp with original signatures and signed within 90 days OR Specific power of attorney (must state authority to apply for U.S. passport or travel documents and be issued within 90 days for this specific child.
- DS -5507, FOR USE UNDER SPECIAL CIRCUMSTANCE WHEN THE U.S. PARENT IS UNABLE TO BE PRESENT.
- Copy of non-applying parents ID (both sides) **used in front of the notary** must accompany the DS-3053/ Specific Power of Attorney
- Deployment/TDY orders for non-applying parent showing current deployment of 30 days or more

- One (1) additional Passport photo of the applicant (2X2)
- \$ 235.00 Total Money Order for Report of Birth Abroad plus Tourist passport: Payable to Department of State
- OR \$100.00 paid through eCRBA, then bring \$ 135.00 Money Order for the Tourist Passport Payable to Department of State

ACTIVE DUTY SPONSOR WISHING TO APPLY FOR REPORT OF BIRTH AND ONLY A NO-FEE PASSPORT: Baby can only travel to US/Germany!
