MEMORANDUM FOR DISTRIBUTION

SUBJECT: USAG Stuttgart Command Policy Letter #13, Warrior Restaurant (Diner Facility) Use

1. Reference:

- a. AR 30-22, Para 3-1 g and 3-37 (The Army Food Program)
- b. AE Reg 550-175, Section VII, Para 29 a (U.S. Forces Customs Controls in Germany)
- 2. Purpose: To provide guidance and procedures pertaining to personnel authorized to subsist in The Originals Café, 1-10th SFG(A) Warrior Restaurant (WR); building 2963, Panzer Kaserne.
- 3. Military service and Family members within the USAG Stuttgart Community may consume meals within the 1-10th SFG(A) WR. If an incoming unit, with a group of fifty (50) or more personnel, is assigned to duty at USAG Stuttgart, the commander of that unit is responsible for informing DFAC management of the adjusted headcount.
- 4. Appropriate and non-appropriate employees, direct hire Local National employees, and Family members may consume meals in the DFAC. Family members and employees will pay the applicable standard meal rate and Family members of E-4s and below will pay the discounted meal rate. Common Access Card and/or dependent ID cards must be in the person's possession at the headcount station.
- 5. When the installation commander determines that it is the best interest of the Government in the form of operational efficiency, morale improvement, or good community relations, and on designated holidays (Thanksgiving, Christmas, Army Birthday, etc.) civilian employees, Family members, Retirees and Local Nationals may purchase meals in an appropriated funded DFAC. However, these personnel are not authorized to purchase meals in any dining facility that exceeds 100 percent utilization rate. Approval to purchase meals other than occasionally will be authorized only when non-appropriated funds or commercial food service facilities are not readily available, or duty assignment precludes departure from the duty area.
