SUBJECT: Authorized Points of Entry (USAG Fort Wainwright Policy #26)

- 1. References.
- a. 18 United States Code, Section 1382, Entering military, naval, or Coast Guard property.
- b. Department of Defense Instruction 5200.08, Security of DoD Installations and the DoD Physical Security Review Board, 10 Dec 05, Incorporating Change 3, Effective 5 Nov 15.
- c. DoD Manual 5200.08 Volume 3, Physical Security Program: Access to DoD Installations, 02 Jan 19.
  - d. Army Regulation 190-13, Army Physical Security Program, 27 Jun 19.
- 2. The following installation access control points are the exclusive means of gaining access to Fort Wainwright:
  - a. Gaffney Gate on Gaffney Road; open 24 hours.
- b. Montgomery Gate at Badger Road and Montgomery Road; open 0500-2000 daily (closed Thanksgiving and Christmas).
- c. Trainer Gate at Trainer Gate Road; open 0530-2000 Monday thru Friday and 0700-2000 Saturday and Sunday (closed holidays).
  - d. Lazelle Gate at Lazelle Road and Canol Road; only opened for special purposes.
  - e. Richardson Gate on South Gate Road; only opened for special purposes.
  - f. DRMO Gate on Chippewa Road; only opened for special purposes.
- g. Sitku Basin Student Pedestrian Gate at Lily Lane and Sitku Basin housing area; only open during school days from 0700-0900 and 1400-1600.
- 3. Hours of operation are subject to change without notice.

SUBJECT: Authorized Points of Entry (USAG Fort Wainwright Policy #26)

- 4. Vehicles and persons seeking access to Fort Wainwright will be screened for valid personnel identification, unauthorized weapons, and contraband. Security personnel are authorized to deny access to Fort Wainwright to anyone who fails to produce valid identification, is found to possess unauthorized weapons or contraband, or is observed acting in a threatening or suspicious manner. All suspected violations of criminal law, including attempts to access Fort Wainwright by any route other than the approved access control points, will be immediately reported to law enforcement.
- 5. This policy supersedes USAG Fort Wainwright Policy #26, Authorized Points of Entry, dated 18 Jan 22.
