SUBJECT: Debarment Orders and Unescorted Access Determinations (USAG Fort Wainwright Policy #31)

- c. Army Regulation (AR) 190-13, The Army Physical Security Program, 27 Jun 19.
 - b. AR 190-45, Law Enforcement Reporting, 27 Sep 16.
- 2. In the exercise of authority granted by 18 U.S.C. § 1382 and as delegated by the Commander, 11th Airborne Division, to bar individuals from entry or access to Fort Wainwright, I hereby direct the following:
- a. Debarment letters may be requested by the Physical Security Division, Provost Marshal's Office, directorate-level supervisors, the Staff Judge Advocate, and tenant unit commanders. Requests for debarment letters must be accompanied by a written statement of reasons for the bar.
- b. Requests for debarment will be submitted through the Director, Directorate of Emergency Services (DES), for endorsement. The DES will forward requests for debarment to the Consolidated Legal Office.
- c. The DES Physical Security Division and Provost Marshal's Office will be provided with:
 - (1) A copy of the letter or order barring the individual from Fort Wainwright;
 - (2) Three identifiers for the barred individual;

- (3) Reasons for the bar; and
- (4) Effective date of the bar and period covered.
- d. The DES Physical Security Division and Provost Marshal's Office will maintain a list of barred or expelled persons. The DES Physical Security Division and Provost Marshal's Office will deconflict and update their respective databases at a least once monthly.
- 3. Having been delegated command authority to make unescorted access determinations and adjudicate denial waivers by the Commander, 11th Airborne Division, I hereby direct the following:
- a. The DES will conduct fitness determinations for visitors, uncleared contractors, and other persons not eligible for a CAC or other form of approved identification. The Director of DES is authorized to deny persons access to the installation based on information indicating that a person may present a threat to the good order, discipline, and morale of the installation.
- b. Access control personnel will issue instructions to denied persons on how and where to submit a denial waiver request.
- c. The Director of DES and Physical Security Division will review and adjudicate all requests for denial waivers. The Director of DES may grant denial waivers based on a revised fitness determination.
- d. If the Director of DES recommends denial of a waiver request, the request and all supporting documentation will be routed through the Consolidated Legal Office.
- e. Copies of the final determination on all denial waiver requests will be provided to the DES and Provost Marshal's Office to update applicable access control databases.
- f. Persons who have had a waiver request denied may request reconsideration one year after the final determination was rendered. All requests for reconsideration will be submitted through the Director of DES to the Consolidated Legal Office.
- 5. This policy supersedes Garrison Policy #31, subject: Debarment Orders and Unescorted Access Determinations (USAG Alaska Policy #31), dated 29 September 2019.
