SUBJECT: Armed Forces Disciplinary Control Board (AFDCB) (USAG Fort Wainwright Policy #28)

References:

 - b. Army Regulation 600-20, Army Command Policy, dated 24 July 2020.
- c. Armed Forces Disciplinary Control Board Memorandum of Agreement, dated 6 March 2018.
- 2. Purpose: The purpose of this policy is to establish an AFDCB to advise and make recommendations on matters adversely impacting the health, safety, welfare, morale, and discipline of the Armed Forces.
- 3. The board will meet quarterly with representation in accordance with the Armed Forces Disciplinary Control Board Memorandum of Agreement (ref. 1.c.).
- 4. The 11th Airborne Division and 1st Brigade, 11th Airborne Division will be invited to send a unit representative to all meetings of the AFDCB.
- 5. The AFDCB will meet to receive reports and take appropriate action on conditions impacting the Fort Wainwright community relating to any of the following:
 - a. Disorder and lack of discipline.
 - b. Prostitution.
 - Sexually transmitted diseases.
 - d. Underage drinking and liquor violations.
 - e. Racial and other discriminatory practices.
 - f. Alcohol and drug abuse.

SUBJECT: Armed Forces Disciplinary Control Board (AFDCB) (USAG Fort Wainwright Policy #28)

- g. Drug paraphernalia.
- h. Criminal or illegal activities involving extremists, cults, or hate groups.
- i. Illicit gambling.
- Areas susceptible to terrorist activity.
- k. Unfair commercial or consumer practices.
- I. Other undesirable conditions deemed unsafe.
- 6. Boards will be conducted in compliance with the procedures established in AR 190-24, Appendix B.
- 7. The AFDCB may invite representatives of local law enforcement and civic organizations to attend. The board is authorized to coordinate with appropriate civil authorities on problems or adverse conditions existing within the local community.
- 8. A report on the board's findings and recommendations will be disseminated to the commanders of all major units and tenant organizations on Fort Wainwright.
- 9. This policy supersedes USAG Fort Wainwright Policy #28, subject: Armed Forces Disciplinary Control Board (AFDCB), dated 18 Jan 22.
