MEMORANDUM FOR United States Army Garrison (USAG) Wiesbaden Community

SUBJECT: Restriction of Movement Standards for Wiesbaden Community

1. References:

- g. General Order Number 1 (amended XX April 2021). COVID-19 Public Health Measures for Personnel within USAG Wiesbaden under the Authority of the Senior Responsible Officer (SRO).
- 2. Applicability: This policy applies to all DoD Service Members (SM), DoD Civilians, Contractors and Family Members assigned to USAG Wiesbaden.
- 3. In accordance with USAREUR-AF policy, all Service Members, DoD Civilians, Contractors and Family Members who meet the requirements outlined by USAREUR-AF are required to conduct restriction of movement (ROM) for a minimum of 10 days immediately upon arrival into theater or potential exposure to COVID-19, in accordance with General Order Number 1 (amended 23 April 2021). This period may be extended if any individual or Family Member tests COVID-19 positive and requires isolation. ROM is required when:
- on official travel from any location for which an exception to policy (ETP) was required to travel;
- on unofficial travel from, or having travelled through, any location for which the Host Nation requires a period of self-isolation or ROM; or

- when conducting permanent change of station (PCS) to USAG Wiesbaden from any location outside of Germany.
- 4. Restriction of Movement Quarters. Individuals in a ROM status must remain in their designated ROM quarters for the duration of the ROM period, will not have face-to-face close contact with anyone except for Family Members, medical personnel, and sponsors in specific circumstances. When authorized to leave their restricted quarters or to go outdoors, and anytime within the presence of non-Family Members, individuals must maintain a personal distance of six feet (two meters). Generally, all individuals 3 years and older will wear a mask, particularly when social distancing cannot be maintained.
- 5. Medical Testing during Restriction of Movement.
 - a. Non-vaccinated service members who PCS into theater will be tested for COVID-19 upon arrival. Additionally, Service Members will be tested a second time for COVID-19 during their ROM on Day 8. As a pre-requisite condition for release from ROM, these 2 tests must be negative.
 - b. Unless otherwise required by a more restrictive DoD or host nation policy, Individuals who are fully vaccinated are not required to undergo testing upon arrival from the United States.
 - c. Individuals fully recovered from a laboratory-confirmed diagnosis of COVID-19 infection within the previous 90 days are not required to undergo viral testing. (requires medical clearance).
 - d. Other individuals will follow guidance from Public Health for determining if they need to be tested for COVID-19. Public Health can test anyone 6 months old and older.
 - e. The USAG-W Trace Team, under the advice of Wiesbaden Army Health Clinic, retains isolation ROM release authority and all individuals will receive a release memorandum upon completion of isolation. Only persons that tested positive will receive a release memo.
- 6. Restriction of Movement Standards and Directives.
- a. Individuals in ROM status residing in stairwell units and the Army Lodge must wear a mask that covers their mouth and nose any time they open their front door or while walking through public areas of the building (ex. stairwells, hallways, and landings). Individuals at the Army Lodge will not enter the lobby, visit the breakfast area, or utilize the gym or other facilities during the restriction of movement period.
- b. Individuals are permitted to spend an unlimited amount of time within the yard of their assigned quarters, their housing unit, or the designated recreation area at the Army Lodge. The yard is defined as the immediate vicinity surrounding a housing unit, the Army Lodge, or a stairwell housing building.
- c. Individuals may conduct Physical Readiness Training (PRT) in their ROM quarters or outside only. They must stay away from all other individuals. While outside, they are not

permitted to enter any buildings, service areas, areas where people are congregating or public areas. Individuals are restricted to on post when conducting PRT and will immediately return to inside their ROM quarters upon completion.

- d. Individuals in ROM will not use playgrounds, public recreation areas, or other outdoor public facilities.
- e. Individuals, 3 years and older, must wear a mask or face covering that covers both their mouth and nose when 6 feet (2 meter) physical distancing is not possible while interacting with non-family members indoors. This includes answering the door of their quarters or the Army Lodge room.
- f. Family Members listed on the Service Member/DoD Civilian orders are the only individuals permitted in the ROM quarters. Non-Family Members, including friends, and colleagues are not permitted in the home, garage or room. Sponsors will minimize time in ROM quarters for essential purposes.
- 7. Authorized Movement. Individuals on restriction of movement are not authorized to leave their designated ROM facility, except as previously stated in paragraph 9, unless directed to do so by an appropriate USAG Wiesbaden Public Health official. Individuals may leave for emergencies involving potential loss of life, limb, or eyesight without prior approval, but will inform their chain of command of emergencies as soon as feasibly possible.
