MEMORANDUM FOR All Members of the United States Army Garrison Wiesbaden Community

SUBJECT: United States Army Garrison (USAG) Wiesbaden Command Policy Letter #27, Prohibited Refuse Disposal Practices

- 2. Purpose: To ensure members of the military community are aware of and adhere to applicable host-nation (HN) laws, Army regulations, and IMCOM-Europe policy on refuse disposal (references 1 a through f).
- Applicability: This policy applies to all Military, Civilian, Local National (LN), and Contractor personnel (as well as their Family members) who work at, reside on or near, or visit local USAG Wiesbaden installations.
- 4. Background: Refuse disposal costs rise dramatically when off-post household waste is improperly disposed of on an installation. Most Department of Defense (DOD) personnel living off-post receive compensation for household waste disposal through living quarters or overseas housing allowances. This means that the U.S. Government pays twice for off-post household waste that off-post residents dispose of on-post. In addition, costs to the garrison for refuse disposal rise dramatically when non-recyclable

refuse is cross-contaminated with recyclable waste. This policy is established to ensure that all personnel are aware of proper disposal procedures and do not waste garrison limited funding.

5. Policy:

- a. Waste receptacles on USAG Wiesbaden installations are clearly marked and dedicated for certain waste streams. All recyclable material is to be sorted and placed into the appropriate container (see attached Waste Separation Guide). This is not only USAG Wiesbaden policy, but is also a matter subject to Host Nation (HN) law.
- b. Users will not transport refuse between installations. Users must properly separate solid waste (non-recyclable from recyclables) and place it in the appropriate container.
- c. It is prohibited to bring non-recyclable refuse (Restmuell) and recyclables generated off-post onto US installations. Residents living off-post must use their city for refuse collection services and local community recycling drop-off points (Recyclinghof). - d. U.S. Government ID cardholders residing on USAG Wiesbaden installations may continue to drop off their recyclable personal property at the community Recycling Center (located at Lucius D. Clay Kaserne, Heinig Street Bldg. 2450) during hours of operation. Customers must follow directions of the Recycling Center Staff, and should not enter or take items from any recycling container. Materials accepted inside include cardboard, wood, metal, yellow bags, textiles and shoes, color sorted glass, green waste, appliances, and electronics. Drop-off point for Military clothing is the 405th Army Field Support Brigade at Bldg. 1036. A Hazardous Waste Accumulation Point (HWAP) is located at the Recycling Center for disposal of the following hazardous waste items: Aerosol Cans, Dry Cell Batteries, Antifreeze, Paint, Ink Cartridges, Waste Oil, Lead-acid Batteries, Flammables, Contaminated Plastic Containers, Contaminated Metal Containers, Fluorescent Light Tube and Cooking Oil. Any other Hazardous Waste (e.g., originated by units) needs to be dropped off at the Hazardous Waste Accumulation Point at Bldg. 1224. Building materials, construction debris or similar wastes may not be dropped off at the Recycling Center. For a complete list of accepted recyclable material please visit

- e. Reuse Facility: This part of the USAG Wiesbaden Recycling Center diverts serviceable and usable items from the solid waste stream and returns them to use. Usable items can be donated and then withdrawn by others for private use only. The Reuse Facility is a non-profit facility restricted to U.S. Government ID cardholders with no guarantee that the items removed are operational. It is a first come first serve facility, therefore no reservations will be made. Items taken from the Reuse Facility should be considered for personnel use only, not for resale, and limited to ten (10) items and one (1) visit per day. Customers acknowledge responsibility and assume liability of items removed from the reuse area with their signature at the entrance to the reuse area. Customers must follow directions of the Reuse Facility staff. In cases of abuse of privileges or unruliness, staff will contact the Military Police to officially ban individuals from the Recycling and Reuse Center.
- f. All individuals within the USAG Wiesbaden community are responsible for adherence to and enforcement of this policy. Incidents of prohibited refuse disposal as described in this policy should be reported to the USAG Wiesbaden Military Police DSN 548-7777 or commercial 0611-143-548-7777. To assist in policy compliance and response, please provide a written description of what was disposed of, when it was disposed, where it was disposed, names of those involved, if known, and a description of vehicle/license plate number to the following email address: usarmy.wiesbaden.imcom-europe.mbx.waste-hotline@mail.mil.

6. Violations:

- a. Civilian personnel who violate this policy may be subjected to adverse administrative action in accordance with (IAW) AER-27-9 and Command Policy Letter #9.
- b. Local Nationals who violate this policy will be subject to administrative actions as appropriate under AER 690-64.
- c. Military personnel who violate this policy will have notification of the violation sent to the sponsor's chain of command for appropriate action (counseling, corrective training, extra duty, etc.). For more severe offences indicating flagrant disregard for this policy, Uniform Code of Military Justice (UCMJ) action may be considered.
- d. Contractors and other foreign nationals who violate this policy may be subject to administrative actions as appropriate under HN law.
- 7. Summary: All individuals within this military community are responsible for adhering to and enforcing this policy.
