## Words of Caution about Attorney Fees

Attorneys do not work for free. If you “win” your case, the other party may pay for your attorney. If you do not “win,” you may end up paying for the other party’s attorney AND your own attorney.

Some attorneys charge a fee for office consultation, even if you choose not to proceed further with the attorney’s service.

Some attorneys require the payment of an advance deposit or retainer fee before they will proceed with your case, while some do not require a retainer.

**If you decide to hire an attorney from this list, make sure you understand the fee arrangements in advance!**
