



Mission

The mission of the USAG Wiesbaden Casualty Assistance Office is to provide compassionate, unwavering commitment to the Families of our fallen Soldiers, Retirees and Veterans. Our office provides assistance to next-of-kin with Benefits Counseling; Military Funeral Honors; and Casualty Assistance / Notification Officer training (CAO/CNO).

Benefits and Entitlements

Surviving spouses of retired and Active Soldiers may receive casualty assistance through these methods:

Live assistance: My office serves as a survivor's advocate who processes Active-Duty benefit claims, coordinates services from support organizations, and answers questions related to entitlements.

Guided assistance: The Casualty Office can also arrange for a Casualty Assistance Officer (CAO) to visit the survivor at a location of choice on a case- by-case basis. The CAO will assist with completion of the forms and serve as a liaison between the survivor and the Casualty Office.

What documents will the Casualty Office require prior to filing benefits:

- 1) The American Death Certificate with the cause and manner of death on it.
- 2) Optional Form 1199-i (International Banks)
- 3) FMS 2231 FASTSTART Direct Deposit (American Banks)
- 4) Marriage Certificate

What documents are required to request consular report of death from the Frankfurt Consulates Office:

- 1) A Consular Report of Death Abroad (CRDA)
- 2) The original German Death Certificate
- 3) The Leichenschauschein which states the Cause and manner of death
- 4) The original passport

What is a Consular Report of Death of a U.S. Citizen Abroad?

AConsular Report of Death of a U.S. Citizen Abroad is: Issued by the U.S. embassy or consulate upon its receipt of the foreign death certificate or finding of death by a local competent authority. More information can be found on the following link below: https://travel.state.gov/
