Notaries in the Wiesbaden Area

This list of local notaries is supplied to authorized Legal Assistance patrons as a public service. This list is not endorsed or in any way approved by the US Army or the US Government. Although we have tried to ensure that this list is up to date, it is possible that changes have occurred (e.g. addresses, phone numbers, etc.).

When a signature is notarized, it is confirmed by official endorsement that the named person signed the document before the notary. Therefore, the signature must be made or acknowledged in person before the notary upon presentation of an official photo ID (valid passport ID card). The person who receives a document certified by the notary can therefore rely on the fact that the signature comes from the person who is named as the issuer. An instruction about the legal meaning of the document to be signed does not take place.

Notaries charge fees for their work according to a fee system laid down by law, which is based exclusively on the business value of the matter. The legislator has chosen this fee system because it offers a number of advantages to the parties involved.

Since they do not depend on the complexity and scope of a matter or on the working time spent by the notary, your notary can tell you the final costs of a planned notarization even before the order is placed. The notary costs are therefore transparent and calculable.

Please note that you must make an appointment, as notaries do not provide any services without an appointment.
