Information about Attorney Fees

German and Poland attorneys normally do not generate a contract for you to sign unless the fee is an hourly rate or a fixed fee. German attorneys typically charge a percentage of the value of the case. If you want the terms of your representation spelled out in writing, ask for it during your initial consultation.

Attorneys do not work for free. If you win your case, the other party may pay for your attorney. If you lose your case, you may end up paying for the other party's attorney <u>AND</u> your own attorney.

Some attorneys charge a fee for office consultation, even if you choose not to proceed further with the attorney's representation.

Some attorneys require an advance deposit or retainer fee before they will proceed with your case, while some do not require a retainer.

If you decide to hire an attorney from this list, make sure you understand the fee arrangements in advance!
