MEMORANDUM FOR All Military Members within the Wiesbaden Community

SUBJECT: USAG Wiesbaden Command Policy Letter #33, Suspension of OF346 and NTV and remedial drivers training for significant speeding violations.

- e. External Standard Operating Procedures for Driver's Testing and Training Station (DTTS).
- 2. Purpose: Establish a modified method by which military and civilian personnel stationed in Wiesbaden, have been issued an OF346, will have their OF346 suspended and receive remedial training after a significant speeding violation.
- 3. Applicability: This policy applies to all Soldiers/Civilians within Wiesbaden Community.
- 4. Effective immediately until rescinded in writing.
- 5. Details: USAG Wiesbaden's safety profile over the past year has shown an increase in significant speeding violations. This number is higher than the last year's average and is our highest source of risk for Soldiers/civilians. In response to this data and after evaluating options with the 405<sup>th</sup> LRC TMP Wiesbaden, the LRC Director has decided to require all Soldier/civilians to attend NTV and remedial training and complete testing at the USAG DTTS. Penalties double for subsequent offenders.
- a. In case of a significant speeding violation of 21-29 kph the OF346 will be suspended for 15 days. The OF346 must be turned in immediately to the ITO (Installation Transportation Officer). The violator has to schedule the NTV and Remedial Training with the WSB DTTS within those 15 days. After passing the knowledge test, the OF346 is reissued after the 15 days suspension. When the test is failed another 15

days suspension occur. Two retests are allowed. After failing the second retest, the OF346 will be revoked permanently.

- b. In case of significant speeding violation of 30 or more kph the OF346 will be suspended for 30 days. The OF346 must be turned in immediately to the ITO (Installation Transportation Officer). The violator has to schedule the NTV and Remedial Training with the WSB DTTS within those 30 days. After passing the knowledge test, the OF346 is reissued after the 30 days suspension. When the test is failed another 30 days suspension occur. There is one retest allowed. After failing the retest the OF346 will be revoked permanently.
- c. If the same person commits another significant speeding violation, the suspensions OF346 is doubled. In addition, the possibilities of a retest will be limited. For 5.a, only one possibility. For 5.b, no retest is allowed.
- 6. Policy: All Soldiers and civilians who have committed a significant speeding offense, will have their OF346 suspended and will be required to attend NTV and remedial training and pass a written test to regain their OF346.
- 7. DTTS schedule details: Monday morning is reserved for ITC scheduled Soldiers. The orientation and test may also be taken on Tuesdays, Wednesdays and Fridays by appointment only. The orientations start at 0730 and end with the completed test at about 1200hrs.
