Vaccine boosters

General Leonard Wood Army Community Hospital no longer offers Pfizer’s COVID-19 booster vaccine – service members may still receive it for compliance with vaccine mandates. Tricare beneficiaries may still receive the Moderna booster vaccine at GLWACH. The U.S. Food and Drug Administration has authorized mixing COVID-19 boosters. Anyone who received the Johnson &

Johnson vaccine more than two months ago; the Pfizer series more than five months ago; or the Moderna series more than six months ago may get either the Pfizer or Moderna booster. Call the GLWACH appointment line at 866.299.4234 to schedule an appointment.

Community testing

Harper Clinic, at 4566 Oklahoma Ave., is now open to the Fort Leonard Wood community for COVID-19 testing and screening from 8 a.m. to 4 p.m. weekdays. Due to supply limitations, personnel will conduct screening and only test as appropriate. Due to supply constraints, personnel may be considered a presumed positive if COVID-19-like symptoms are present. Anyone requiring medical attention should contact their primary care manager, or, if symptoms require emergent care, go to the nearest emergency department.

LEONARD WOOD JUSTICE

Court Martial

— A staff sergeant pleaded guilty at a special court-martial to developing a personal relationship with a trainee. The military judge sentenced him to reduction to private (E-1) and a bad conduct discharge.

Reprimands

- A captain received a General Officer Memorandum of Reprimand for failing to report due to intoxication.
- A second lieutenant received a General Officer Memorandum of Reprimand for driving while under the influence of alcohol.
- A second lieutenant received a General Officer Memorandum of Reprimand for making lewd and unwanted sexual comments to fellow officers.
- A sergeant first class received a General Officer Memorandum of Reprimand for an inappropriate sexual relationship with a woman not his spouse, and for a false official statement.

Other Misconduct

- A staff sergeant was separated from the Army with a general discharge for driving while under the influence of alcohol.
- A specialist received nonjudicial punishment by a field

grade officer under Article 15, UCMJ for wrongful use of a controlled substance. Reduction to private (E-1).

- A specialist received nonjudicial punishment by a field grade officer under Article 15, UCMJ for wrongful distribution of a controlled substance. Reduction to private first class, extra duty and restriction for 45 days, forfeiture of \$2,160 pay, suspended for 180 days.
- A specialist received nonjudicial punishment by a company grade officer under Article 15, UCMJ for violating a pass privilege and failing to report. Reduction to private first class, extra duty and restriction for 14 days.
- A private first class received nonjudicial punishment by a company grade officer under Article 15, UCMJ for an inappropriate relationship with a fellow trainee. Reduction to private (E-2), extra duty and restriction for 14 days.
- A private first class received nonjudicial punishment by a company grade officer under Article 15, UCMJ for writing sexually explicit statements about a drill sergeant. Reduction to private (E-2), extra duty and restriction for 14 days.

NOTE: Soldiers administratively separated receive one of three characterizations of service: Honorable, General, or Other Than Honorable. Anything less than Honorable may result in the loss of certain benefits and negatively impact employment and education opportunities.

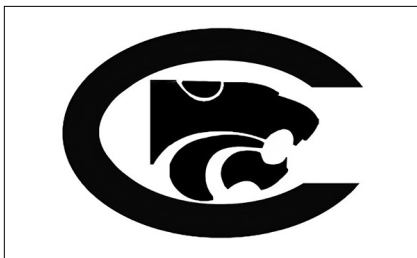


Hayden Fane, Rolla High School

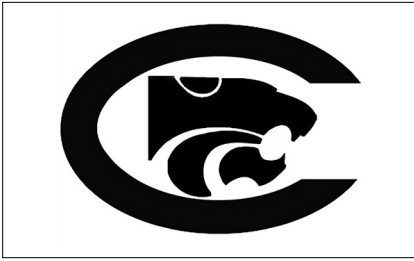
Olivia Nowland, Cuba High School
