# HEROES OF THE BATTLEFIELD

**Staff Sgt. William Beuch**, a drill sergeant with Company D, 1st Battalion, 48th Infantry Regiment, took immediate action in responding and saving a trainee's life. During lunch at a dining facility, he noticed a trainee struggling to breathe, and upon engaging and realizing the trainee was choking on his food, Beuch conducted the Heimlich maneuver to successfully clear the blockage and save the trainee's life.



**Sauci Barrett**, showed why she is a great asset to the Maneuver Support Center of Excellence during the U.S. Army Training and Doctrine Command military intelligence personnel security staff assistance visit. Not only does Fort Leonard Wood have the lowest security hold-over rate across TRADOC, but Barrett's work was used by TRADOC to refine inspection criteria and produce a PER-SEC standard across the command.

## LEONARD WOOD JUSTICE

### U.S. Magistrate Court

- A specialist pleaded guilty to careless and imprudent driving; fined \$750.
- A civilian dependent pleaded guilty to careless and imprudent driving; fined \$540.
- A specialist pleaded guilty to driving while intoxicated; fined \$540.
- A Department of the Army Civilian pleaded guilty to exceeding the posted speed limit by 1 to 5 mph; fined \$360.
- A contractor pleaded guilty to exceeding the posted speed limit by 6 to 19 mph; fined \$350.
- A warrant officer pleaded guilty to exceeding the posted speed limit by 1 to 5 mph; fined \$260.
- A captain pleaded guilty to exceeding the posted speed limit by 6 to 19 mph; fined \$235.

### Courts-Martial

- A specialist was found guilty of conspiracy to commit armed robbery; sentenced to six months confinement, reduced to private (E-1), and a bad-conduct discharge.

### Reprimands

- A staff sergeant received a general officer memorandum of reprimand for driving while under the influence of alcohol.
- A drill sergeant received a general officer memorandum of reprimand for sexually harassing several trainees,

- creating a hostile environment and unlawful discrimination against trainees.
- A sergeant received a general officer memorandum of reprimand for driving while under the influence of alcohol.

### Other Misconduct

- A private was punished under Article 15 by a field grade officer for failing to obey an order by traveling without a mileage pass over the prescribed amount and lying to a commissioned officer. Reduction to private (E-1), forfeiture of \$916 pay for two months (suspended); extra duty and restriction for 45 days (suspended).
- A private was punished under Article 15 by a field grade officer for using Delta 8 THC (a cannabinoid). Forfeiture of pay of \$847.00 per month for two months (suspended), extra duty and restriction for 45 days.

NOTE: Soldiers administratively separated receive one of three characterizations of service: Honorable, General, or Other Than Honorable. Anything less than Honorable may result in the loss of certain benefits and negatively impact employment and education opportunities.

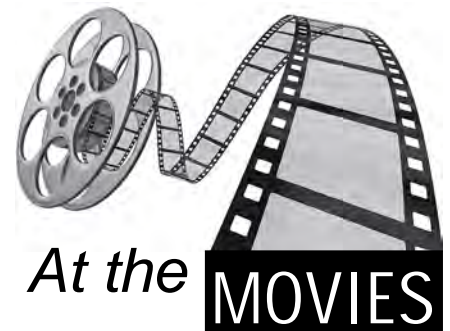

### What brought you to Fort Leonard Wood?

I told my wife that if she followed me around for 20 years in the Air Force, we could live wherever she wanted to live. We chose here, because my family is in Columbia, Missouri, and her family is a few miles away from our house. I am from here and we wanted to come home after we got done with the military.

### What is your favorite part about being a DA Civilian?

My favorite part is the emails I get thanking me for what I do. People tell me how they were once in a bad place where they, or a family member, needed blood, and that if it wasn't for blood donors, they wouldn't be here. It really

motivates me and keeps me going, knowing that because of what we do here, somewhere in the world today, somebody is going to get blood that we've collected, and that's going to help them live or recover from a disease.

### What advice would you give to others who are thinking of becoming a DA Civilian?

It can be a bear to get into the civilian system, but once you're here, you have not only job satisfaction and stability, but you're doing something that's going to help this nation. Whatever you're doing as a DA Civilian, you're helping Soldiers, Sailors, Airmen and Marines remain ready to fight when the need comes. If there's anything you feel real compassion about, pursue it in the DA Civilian world, because you get more

satisfaction out of that than you would any place else.

### Why did you choose to become a DA Civilian?

I was in Public Affairs with the Air Force and really enjoyed what I did. I knew they hired civilians in the Public Affairs world, and I wanted to keep doing something I enjoy while continuing to serve my country.

### What are the benefits of working as a DA Civilian?

For me, it's the satisfaction I get knowing I've served a purpose and done something that's going to help somebody. I don't just have a job. This is something that is going to really reach out and help somebody on a personal level, and something I enjoy doing.
