The Military Police Investigator Course trains enlisted military personnel from the Army, Air Force, Navy and Marines, and selected civilian personnel, to investigate crimes through lessons on: Criminal Law, Crime Scene Processing, Testimonial Evidence, Investigations of Crimes against Persons and Property, Physical Evidence, Drug Investigations, Investigative Reports, Special Investigative Techniques, and Economic Crimes.

Special Information:

Information listed below applies to all Army Soldiers except IET and MOS-Transition.

Effective immediately, unvaccinated students (Service Members and DoD Civilians) attending PME and/or Functional Training must have an ETP approved by the Under Secretary of the Army to travel and be enrolled into a course. All students are required to provide proof of vaccination (vaccination card and/or DD Form 3175) or an approved Exception to Policy that is IAW DoD Standards for course attendance. Should an unvaccinated student arrive to training without an approved ETP for travel will not be accepted into the class and directed to return to their home station.

Height/weight standards across all TRADOC courses will be enforced IAW AR 350-1 para 3-13.

2. Army Soldiers except IET and MOS-Transition will report to the IHG Lodging Office, Candlewood Suites, 4990 Nebraska Ave, Bldg 2020, Commercial 573-586-4800, or 1-800-677-8356 for room assignment in the IGH lodging complex. All TDY Soldiers arriving after duty hours, weekends, and holidays report to the IOC Watch Officer located in HQ MSCoE, Hoge Hall, Bldg 3200, Room 110, 573-563-6126.
3. MOS-Transition and IET Soldiers will report to unit or Military Personnel Division, Student In-processing, Bldg 470, Room 2118, during duty hours. Soldiers will report to 43rd AG, Bldg 2100 during non-duty hours.
4. Soldiers coming to Fort Leonard Wood for AIT training must bring a copy of their DA Form 93 (Record of Emergency Data), a copy of their DA Form 8286 (Service Members Life Insurance), and current orders / 1610 attaching/assigning them to FLW.
5. IAW HQDA DCS G-3-5-7 ALARACT R281417Z Aug 17 and Institutional Training Directed Lodging and Meal Policy Handbook, Section 2-1.d. (page 10), lodging will only be covered for students with Valid Reservations (R) in ATRRS utilizing the central billing process. The sending command will be required to fund students that report without a Valid Reservation status in ATRRS. Wait status (W) is not a valid reservation and will not be centrally funded.
6. Transportation information is as follows:
 - a. If driving, the most direct route is by Interstate 44 that runs between St Louis and Springfield, MO.
 - b. If traveling by air to St Louis: Coach (\$85.00 one way) and commercial bus lines (approximately \$30.00 one way weekdays & \$35.00 one way for weekends) or rental car are available for transportation. Rental cars are recommended as shuttle services are limited. Fort Leonard Wood is approximately 120 miles southwest of St. Louis.
 - c. If traveling by air through Chicago: SkyWest offers daily direct flights to Fort Leonard Wood airport (TBN) from Chicago Ohare.
 - d. If traveling by air to Springfield: Rental car is the only transportation available. Ft Leonard Wood is approximately 90 miles northeast of Springfield.
 - e. Daily transportation to and from classes will be provided for all Initial Entry Training (i.e. Advanced Individual Training, One Station Unit Training, MOS-Transition).
 - f. Government transportation is provided for all USAR TASS Battalion students to meet lodging, class and meal requirements.
 - g. Commercial taxis are available on a 24-hour basis in and around post.
 - h. In and around mileage for resident service school students that travel by POV may be authorized by the order issuing official.
7. Meal Subsistence:
 - a. Soldiers attending IET and MOS-Transition courses will subsist at installation dining facilities seven days per week at no cost to the Soldier.
 - b. All USAR TASS Battalion students along with the administrative staff and cadre will subsist at the installation dining facilities seven days per week at no cost to the Soldier.
 - c. All other TDY Army Soldiers housed on the Installation training under school code 191, will subsist at installation dining facility 7 days per week. Cost of meals are centrally funded and provided at no cost to the soldier. Meal Per Diem is not authorized. Soldiers should be assigned Meal Entitlement Code (MEC) 05 on their Common Access Card (CAC) by their permanent duty location S-1 PRIOR to arriving. CAC will be used at the DFAC. Meals are authorized from class start date to class end date.
 - d. Active component students attending the CAPIT 7H-F43 (RF) (MC) and DVIT 7H-F57/830-F20 (RF) (MC) courses are not funded under ITDLM and will be authorized the proportional meal per diem rate by their order issuing official.
8. NG and AR CAPIT/DVIT course students are funded under ITDLM and must coordinate lodging with IHG Army Lodging, (573) 586-4800, upon notification of course attendance.
9. Due to limited billeting, students are recommended to not bring their dependents to school with them. Students will not bring privately owned weapons with them to school. Pets are not allowed.
10. Students will in process in duty uniform IAW AR 670-1.
