MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Memorandum of Instruction (MOI) for MSCoE Portable Electronic Device (PED) Basis of Issue Plan (BoIP)

1. Reference. Army Directive 2019-23 (Allocations of Commercial Wireless Devices).

2. Purpose. To establish a Basis of Issue Plan for all Portable Electronic Devices and O6 approval for waivered PEDs required by Army Directive 2019-23. This will also establish review procedure of the BoIP and frequency along with procedures for overseas travel requiring PED service.

3. Information Technology (IT) Steering Committee Responsibility.

a. The committee is responsible for reviewing the PED BoIP on an annual basis as listed in Enclosure1. This annual review will take effect during the 1st Quarter of each Fiscal Year.

b. The committee will validate existing PED BoIP. Any changes that exceed the current plan will be presented to the SRPRAC for approval.

4. Army Directive 2019-23 O6 approval.

a. This MOI will serve as the O6 waiver approval for all devices listed on the PED BoIP not authorized in Enclosure 1.

b. The Commandants at their discretion may approve up to five phone devices for use or use as floats along with two iPads and three MiFi (mobile Wi-Fi hotspot). Exceptions beyond the five additional phones is retained by the MSCoE Chief of Staff.

c. Brigade Commanders may approve up to two phone devices. The phone devices may be assigned or used as floats. Exceptions beyond the two additional phones is retained by the MSCoE Chief of Staff.

d. MSCoE Chief of Staff is responsible for approval of all MSCoE staff devices.

5. OCONUS Travel:

a. The traveler will request to have OCONUS phone access activated upon approval of the TDY authorization.

b. The traveler's organizational Telephone Control Officer (TCO) will ensure the phone is configured for OCONUS phone access NET two (2) days prior to travel. The TCO will remove OCONUS phone access NLT five (5) days after traveler returns to home station.

6. Proponency. The proponent for this MOI is the MSCoE G-6.
