MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Command Policy 8, Off-Limits Establishments

1. Reference. Army Regulation (AR) 190-24/OPNAVINST 1620.2A/AFI 31-213/MCO 1620.2D/COMDTINST 1620.1E, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations, 27 July 2006.

2. Purpose. This policy lists the establishments that are designated as off-limits to military personnel.

3. Applicability. This policy applies to all Service members permanently or temporarily assigned, attached, with duty, or present on Fort Leonard Wood, Missouri.

4. Policy. The following establishments are declared off-limits to military personnel. Service members are prohibited from visiting, entering, or patronizing these establishments, regardless of their duty status. These establishments will remain off limits even if there is a change in name, location, ownership, or management of the establishment.

- a. Mad Hatter's Emporium, located at 644 Old Route 66, Suite A, St. Robert, MO.
- b. High Profile Cannabis Shop, located at 231 Saint Robert, Blvd., St. Robert, MO.
- c. Vapor 100, located at 151 St Robert Blvd #2, Saint Robert, Blvd., St. Robert, MO.
- d. Alice's Apothecary, located at 658 U.S. Rte. 66, Saint Robert, MO.
- e. J & J Garden Supply, located at 318 W Historic 66, Waynesville, MO.


5. Punitive Provision. Paragraph 4 of this policy is punitive. Military personnel observed in off-limits establishments are in violation of a lawful general order and are subject to adverse administrative action or punishment under the Uniform Code of Military Justice (UCMJ), or both.

6. SUPERSESSION. This policy supersedes the FLW and MSCoE Command Policy 8, dated 19 May 2023, subject as above, and remains in effect until superseded or rescinded.
