SUBJECT: Garrison Policy 04, Operating a Taxi on Fort Leonard Wood

1. References:

- a. Army Regulation 210-7, (PERSONAL COMMERCIAL SOLICITATION ON ARMY INSTALLATIONS), 18 October 2007
- b. TRADOC Regulation 350-6, (ENLISTED INITIAL ENTRY TRAINING POLICIES AND ADMINISTRATION) 30 January 2018
- 2. Purpose: To provide guidance regarding the operation of a taxi service on Fort Leonard Wood.
- 3. Applicability: This policy applies to all military and civilian personnel, including appropriated and non-appropriated fund employees, as well as family members, visitors, volunteers, or contractors at Fort Leonard Wood.

4. Policy:

- a. Reference A prescribes general policy on the solicitation and sale of all goods, services and commodities on the installation. It further states that no person has the right to conduct commercial activity on the installation absent written permission from the Garrison Commander. This applies to all taxi services including independent contractors.
- b. Reference B forbids interaction of a commercial nature between trainers and trainees. Persons subject to this policy letter will not be issued written permission to conduct commerce on the installation.
- c. Proof of required written permission will be enforced at the entry to the installation. An active duty, dependent, retiree or CAC access card is not evidence of written permission to conduct commerce on the installation.

SUBJECT: Garrison Policy 04, Operating a Taxi on Fort Leonard Wood

d. Operation of a taxi on Fort Leonard Wood under the issued license for said service shall be governed by the license.

5. Background:

- a. Fort Leonard Wood has regulated taxi service on the installation through a solicited license. Only the licensee may pick up fares on the installation. Drop off service is controlled by issuing permits granting access to the installation. Only taxi operations that have these permits are allowed access to the installation. Persons are not to use active duty, retiree or CAC cards for access to the installation to conduct commerce.
- b. Online independent contractor services have created situations that could infringe upon both references by conducting commerce without permission from the Garrison Commander and creating an impermissible trainer/trainee relationship.
- 6. Punitive Effect: Violation of this policy by military personnel is punishable as an offense under Article 92 of the Uniform Code of Military Justice. Violation by any other person may subject the violator to adverse administrative action or debarment from the installation.
