Fort Leonard Wood Soldiers assist in Army altitude study in New Mexico

Forty-nine Soldiers from the 5th Engineer Battalion here spent four days at Taos Ski Valley, New Mexico, this past summer, taking part in an altitude study conducted by the U.S. Army Research Institute of Environmental Medicine.

U.S. Magistrate Court (Held in the OSJA Courtroom, Sept. 22)

A civilian contract employee pleaded guilty to manufacturing liquor without a proper license; \$750 fines and fees.
A sergeant pleaded guilty to driving under the influence

of alcohol; \$540 fines and fees. — A specialist pleaded guilty to driving under the influence of alcohol; \$540 fines and fees.

A retired major pleaded guilty to operating a motor vehicle in a careless and imprudent manner; \$340 fines and fees.
A civilian visitor pleaded guilty to trespass and unlawful possession of drug paraphernalia; \$335 fines and fees.

A captain pleaded guilty to speeding; \$180 fines and fees.
A staff sergeant pleaded guilty to speeding; \$180 fines and fees.

Reprimands

 A second lieutenant received a General Officer Memorandum of Reprimand for fraternizing with a drill sergeant.
A sergeant major received a General Officer Memorandum of Reprimand for engaging in counterproductive leadership by refusing to listen to subordinates, dishonesty and exhibiting poor self-control.

— A sergeant first class received a General Officer Memorandum of Reprimand for fraternizing with a commissioned officer. — A sergeant received a General Officer Memorandum of Reprimand for extramarital sexual conduct with a woman not his spouse.

Other Misconduct

— A sergeant first class was punished for methamphetamine use under Article 15 by a field grade officer. Forfeiture of half a month's pay for two months (suspended); separation initiated.

— A private (E-2) was punished for cocaine use under Article 15 by a field grade officer. Reduction to private (E-1); forfeiture of half a month's pay for one month; extra duty and restriction for 45 days.

— A private (E-2) was punished for an inappropriate relationship under Article 15 by a field grade officer. Reduction to private (E-1); forfeiture of half a month's pay for two months (suspended).

NOTE: Soldiers administratively separated receive one of three characterizations of service: Honorable, General, or Other Than Honorable. Anything less than Honorable may result in the loss of certain benefits and negatively impact employment and education opportunities.

These volunteers come from the pool of candidates who applied in March 2021 and members who are currently assigned to units already slated to transfer.
