## **Peak PCS season delays**

Personnel preparing for a permanent change of station should anticipate delays in the scheduling of their household goods move, and should not try to move or store their household goods prior to receiving PCS orders. Individuals should contact the Fort Leonard Wood transportation office when orders are received - any delay in contacting the transportation office may result in non-availability of Department of Defense-contracted moving companies. Call 573.596.0077, or visit in person in Bldg. 470, Room 1220. The transportation office is open from 8 a.m. to 3 p.m. weekdays. Customers also have the option to start the process on-line through the Defense Personal Property System. To request access to DPS, click here. ## Bridge improvements over I-44 to affect Fort Leonard Wood traffic

A Missouri Department of Transportation construction project set to begin June 12 will close eastbound Exit 161 off Interstate 44, and affect northbound and southbound traffic across the Y Highway/Missouri Avenue bridges over the interstate. One lane will remain open in each direction on the bridges during the project, which is expected to take about four months.

# LEONARD WOOD JUSTICE

## **Courts Martial**

— A staff sergeant was convicted at a General Court Martial of committing domestic violence (strangulation) in violation of Article 128b, UCMJ, and was sentenced to 10 months of confinement, reduction to E-1, and a bad-conduct discharge.

## Reprimands

— A sergeant first class received a permanently filed general officer memorandum of reprimand for driving under the influence of alcohol.

— A staff sergeant received a general officer memorandum of reprimand and a relief-for-cause NCO evaluation report for violating U.S. Army Training and Doctrine Command Regulation 350-1, and for behaving in an abusive manner toward trainees.

— A specialist received a permanently filed general officer memorandum of reprimand for driving while under the influence of alcohol.

## **Other Misconduct**

— A staff sergeant, serving as a drill sergeant, was involuntarily separated from the Army for attempting to develop a personal relationship with a trainee. — A specialist received a Company Grade Article 15 for failure to report on multiple occasions. Reduced to private first class.

— A private (E-2) received a Company Grade Article 15 for disrespect to a commissioned officer and disrespect to an NCO. Reduction to E-1 and forfeiture of one-half month's pay for one month, suspended for 14 days, and placed on restriction for 14 days. — A private (E-2) received a Company Grade Article 15 for violating a lawful order by being in a barracks section that was designated for the opposite sex.

— A private (E-1) received a Field Grade Article 15 for failing to obey a lawful order. Forfeiture of \$958 of pay per month for two months, 45 days extra duty.

NOTE: Soldiers administratively separated receive one of three characterizations of service: Honorable, General, or Other Than Honorable. Anything less than Honorable may result in the loss of certain benefits and negatively impact employment and education opportunities.

## Slow down when passing service members

Per FLW Regulation 190-5, vehicle operators should drive no more than 10 mph when passing troops marching or standing in formation.

# What brought you to Fort Leonard Wood?

When I was getting my degree (Bowersox completed a bachelor's degree in aerospace engineering at the University of Alabama. in Huntsville. Alabama. in 2020), I knew I wanted a career with the Department of Defense or with a contractor supporting the warfighter. I applied to positions at some of the larger companies - I even applied to companies I'd never heard of that had a job in my field - but I didn't have the experience. I never cared where it was, since I have moved 12 times already. I interviewed for a position in municipal services here and received the tentative offer and accepted it in the airport on the way to a wedding less than a week later.

What is the best part about your job?

I enjoy not being attached to a desk

all the time – that's what I like most. One of the benefits of this job is I can get out there and see things in person. In fact, one of my favorite memories is the time I was trying to figure out where to go on the map, and I was standing next to a river. I couldn't help but just think, "I am so lucky; this is beautiful right now – just me and the river all alone. This is nice."

# What are some benefits to becoming an Army civilian?

The Army and the other branches train you to where you need to be, then support your future goals for personal and professional development. For example, in my current position, it was well known that my closest HVAC experience was designing and building a table-top wind tunnel. In the private sector, unless you get lucky, you need to show up ready to run.

## What advice would you give to individuals considering a career as an Army civilian?

Be honest about your skills and try to be candid and not too formal in the interviews. For the municipal services interview, I was asked "Are you sure this is what you want, because this is nowhere near what you have done before?" I responded with, "Sir, I just need something to get started. I will work hard and do my best to excel."
