HEROES OF THE BATTLEFIELD

Military

Staff Sgt. Alexander Abbruzzese, Sgt. 1st Class Joshua Rainwater and Pvt. Edson Coronado, 31st Engineer Battalion, deserve recognition for their efforts toward improving Army Combat Fitness Test scores. Abbruzzese led the development of a comprehensive, strength-based program to implement on muscular strength and endurance days during physical training. This model has been successful, seeing improved ACFT scores. Rainwater has been actively engaged in this model's implementation, and his leadership has supported the success of dozens of trainees. On March 12, Coronado achieved a score of 600 during the Blue

Phase ACFT. Since this model is showing early success, MSCoE will be using it as a best practice.

Civilian

Kristina Stump, an Army Emergency Relief specialist at Army Community Service, played an integral role in obtaining a 100-percent grant for three trainees' flights home for emergency leave. Without her efforts, professionalism and subject knowledge, these trainees would have never been able to get home and see their loved ones during family emergencies. Her support to our Soldiers and their well being is truly remarkable.



LEONARD WOOD JUSTICE

Courts-Martial

— United States v. Monticello: The accused was found guilty of three specifications of attempted unauthorized use of a credit card. He was sentenced to three months of confinement, forfeiture of two-thirds pay for six months, and a Bad Conduct Discharge.

— United States v. Guterrez: The accused was found guilty of one specification of abusive sexual contact and one specification of assault. He was sentenced to 30 days confinement and forfeiture of two-thirds pay for one month.

Reprimands

— A captain and a first sergeant received permanently filed General Officer Memoranda of Reprimand for allowing cadre to engage in extensive trainee abuse while under their supervision.

— A captain received a permanently filed General Officer Memorandum of Reprimand for wrongful use of a controlled substance. He is currently undergoing officer elimination proceedings.

— A staff sergeant received a permanently filed General Officer Memorandum of Reprimand for driving while under the influence. The staff sergeant is undergoing drill sergeant removal proceedings.

Other Misconduct

— A captain was found guilty at a General Officer Article 15 for conduct unbecoming an officer and a gentleman. He was sentenced to forfeiture of half a month's pay for two months. He is currently facing officer elimination proceedings.

— A second lieutenant was recommended for elimination with a General, Under Honorable Conditions characterization, for wrongful use of a controlled substance.

— A staff sergeant was separated with an Other Than Honorable discharge, in lieu of court-martial, for arson, drunk and disorderly conduct, and driving while under the influence.

— A private was found guilty at a Field Grade Article 15 for sexually harassing six female trainees. He was sentenced to forfeiture of half a month's pay for one month. He is currently facing administrative separation.

NOTE: Soldiers administratively separated receive one of three characterizations of service: Honorable, General, or Other Than Honorable. Anything less than Honorable may result in the loss of certain benefits and negatively impact employment and education opportunities.
