Annual AER fundraising campaign ends June 15

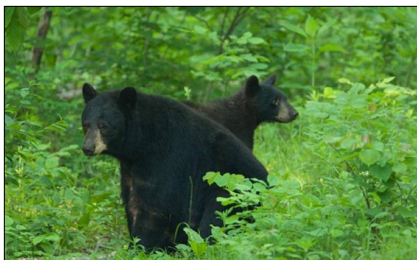

The face-mask policy has been updated. Fully vaccinated Department of Defense personnel — 14 days after final dose — are no longer required

to wear a face mask while indoors or outdoors here. DOD personnel will continue to comply with Centers for Disease Control and Prevention guidance regarding wear of masks in airports and taxis. Additionally, masks will be worn by DOD personnel in medical and dental treatment facilities. Anyone not yet fully vaccinated must continue to wear a mask inside installation facilities and outdoors when social distancing cannot be maintained.

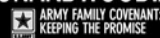

HEROES OF THE BATTLEFIELD

Fort Leonard Wood's Army Emergency Relief contact team is made up of two Soldiers — **1st Lt. Rom Pollack** and **Sgt. 1st Class Steven Hooper** — and one Department of Defense civilian — **Chuck Matthews**. Together, they have contacted more than 6,000 Soldiers, civilians and retirees, with well over half of those donating to AER. They are inspiring communicators, explaining the need for Soldiers to help Soldiers and yielding results, and are deserving of recognition.



For their successes in hiring seasonal civilian employees for recreational and morale-building services, **Maj. Donovan Herron** and **Ace Harden** deserve recognition. While multiple Family and Morale, Welfare and Recreation team members were involved, Herron led the overall efforts for hiring activities by identifying requirements and making connections with community members. Harden adjusted his schedule to accommodate after hours fingerprinting requirements.

LEONARD WOOD JUSTICE

Courts-Martial

— A staff sergeant plead guilty at a Summary Court-Martial to four counts of wearing unauthorized badges in violation of UCMJ, Article 106a. The NCO was reduced in rank to sergeant.

Reprimands

— A captain received a General Officer Memorandum of Reprimand for forging his leave form. Following his reprimand, the General Officer Show Cause Authority initiated elimination proceedings..

— A sergeant first class received a General Officer Memorandum of Reprimand for carrying a concealed firearm and possessing unregistered firearms at his on-post residence.

— A staff sergeant received a General Officer Memorandum of Reprimand for refusing to provide a breath sample after arrest for Driving Under the Influence of Intoxicants.

— A staff sergeant received a General Officer Memorandum of Reprimand for attempting to interfere with a criminal investigation.

— A staff sergeant received a General Officer Memorandum of Reprimand for Driving Under the Influence of Alcohol.

Other Misconduct

— A sergeant received nonjudicial punishment pursuant to UCMJ, Article 15 from the commander for disrespect

towards officers on Tik Tok. The Soldier was reduced in rank to specialist; forfeited half a month's pay for two months; and received 30 days of extra duty.

— A specialist received nonjudicial punishment pursuant to UCMJ, Article 15 from the commander for disrespect towards a noncommissioned officer and violating lawful written orders. The Soldier was reduced in rank to private first class; received extra duty for seven days; and was restricted to the limits of the company area, dining/medical facilities, and place of worship for seven days.

— A specialist was separated from the Army with an Other Than Honorable Discharge for sexually harassing female trainees while in basic training.

— A private was separated from the Army after the commander imposed nonjudicial punishment pursuant to UCMJ, Article 15 for wrongful use of drugs.

— A private was separated from the Army with an Other Than Honorable Discharge for engaging in a sexual relationship with cadre.

NOTE: Soldiers administratively separated receive one of three characterizations of service: Honorable, General, or Other Than Honorable. Anything less than Honorable may result in the loss of certain benefits and negatively impact employment and education opportunities.
