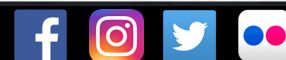

Army aims to assist Soldiers during turbulent moving season

To aid Soldiers during a challenging permanent change of station season, which is seeing some delays with household goods shipments due to the current environment, the Army has widened the window for Soldiers to report to their next duty station.

HEROES^{OF}THE BATTLEFIELD

Spc. Brian Henson, a medic assigned to the Combat Training Company, was supporting Expert Soldier Badge and Expert Infantry Badge validations when he noticed one of the participants swaying and wobbling during a ruck march. Henson's keen observation resulted in correctly identifying, evacuating and treating the individual for a heat injury. His personal, life-saving measures may have saved a life. We are grateful for engaged teammates like Henson.

As an Urban Search and Rescue instructor, **Cody Deckard** teaches basic life support, including CPR and defibrillators. He is certified to teach Red Cross BLS. In addition to his instructor role, he has partnered with General Leonard Wood Army Community Hospital to train units on post.

Deckard is also a certified paramedic with the state of Missouri. He is a phenomenal example of "Victory through skill" and is a great teammate to all organizations on post.



LEONARD WOOD JUSTICE

Courts-Martial

— A captain plead guilty at a General Court-Martial to two specifications of rape of a child, one specification of rape, and one specification of sexual assault. The officer was sentenced to 17 years confinement, forfeiture of all pay and allowances, and a dismissal from the Army.

Reprimands

— A second lieutenant received a permanently filed General Officer Memorandum of Reprimand for driving while intoxicated. Separation from the Army initiated.

— A staff sergeant received a permanently filed General Officer Memorandum of Reprimand for driving while intoxicated.

— A specialist received a permanently filed General Officer Memorandum of Reprimand for driving while intoxicated.

Other Misconduct

— A staff sergeant was discharged from the Army in lieu of trial by Court-Martial and reduced to Private (E-1) with a characterization of service of Under Other Than Honorable Conditions for wrongfully engaging in sexual intercourse with a trainee, wrongfully attempting to develop

and conduct a personal and intimate relationship with a trainee, and for sexual intercourse with a person not his spouse.

— A private first class received nonjudicial punishment pursuant to UCMJ, Article 15 for disobeying his non-commissioned officer by failing to report to training with required TA-50. The commander punished the Soldier with extra duty for three days.

— A private first class received nonjudicial punishment pursuant to UCMJ, Article 15 for disobeying a lawful general regulation by wrongfully engaging in a personal relationship with another trainee. The commander punished the Soldier with extra duty for 10 days.

NOTE: Soldiers administratively separated receive one of three characterizations of service: Honorable, General, or Other Than Honorable. Anything less than Honorable may result in the loss of certain benefits and negatively impact employment and education opportunities.
