Guideline 2: Security Guard Minimum Training Tasks

1. Security Forces Activities

TLO: Understand the role of security in the maintenance of law and order as well as the primary missions undertaken.

2. Ethics and Code of Conduct

TLO: Conduct operations in keeping with the service/agency code of conduct and ethical decision-making processes.

3. Authority and Jurisdiction

TLO: Employ security-based authority to protect property and persons on and around that property in keeping with the code of conduct and federal and agency policies.

4. Interpersonal Skills

TLO: Employ techniques to successfully de-escalate conflict.

TLO: Assess and manage a situation with an impaired or emotionally disturbed person considering the unique requirement of the situation.

TLO: Conduct a field interview to capture basic information from a specific individual including enough contact information to reach back should additional information be required.

5. Communications Discipline

TLO: Communicate clearly with support assets.

6. Administrative Searches & Inspections

6.1 Inspection Authority

TLO: Conduct a lawful inspection according to agency policy, federal law, and Constitutional standards.

6.2 Individuals

TLO: Inspect an individual for contraband or weapons in a manner that safeguards life and property.

6.3 Vehicles

TLO: Inspect a vehicle for evidence or contraband in a way that safeguards life and property.

6.4 Building

TLO: Inspect a structure for evidence or an individual in question.

6.5Areas

TLO: Inspect an area to locate evidence or an individual in question.

7. Building and Repository Checks

TLO: Respond to alarm.

8. Active Threat Response

TLO: Respond to a threat.

TLO: Execute the emergency action plan.

9. Security Officer Survival/Safety

9.1 Control Tactics

TLO: Gain control of a subject based on the perception of the subject actions, legal authority, and what is objectively reasonable according to constitutional standards.

9.2 Handcuffing

TLO: Handcuff a compliant or noncompliant subject to gain or maintain control.

9.3 Cover and Concealment

TLO: Use cover and concealment to achieve a tactical advantage.

9.4 Transporting Offenders

TLO: Transport an offender.

10. Secure a Crime Scene/Protect Evidence

TLO: Preserve a crime scene for investigative purposes.

11. Bomb Threat Procedures

TLO: Respond to and mitigate exposure to a reported or suspected bomb threat or employ post-blast procedures to safeguard life and property.

12. Force Protection/Operational Security

12.1 Threat Levels and Force Protection Conditions

TLO: Operate within Terrorist Force Protection Conditions (FPCONs).

12.2 Threats to Installation and Resources

TLO: Safeguard operational resources.

12.3 Access Control

TLO: Apply the various levels of access control.

13. 1st Responder Medical

13.1 First Aid

TLO: Provide basic emergency medical care for illness or injury in a permissive or nonpermissive environment until emergency medical personnel arrive.

13.2 Blood-Borne Pathogens

TLO: Protect yourself from blood borne pathogens.

14. Use of Force

TLO: Recognize the legal standards for using force.

TLO: Determine the reasonable amount of force necessary to stop the actions and/or control the subject.

TLO: Qualify on assigned lethal and less lethal weapons, as applicable.

15. CBRNE/HAZMAT

TLO: Employ assigned PPE, according to agency/service policy.
