History. This publication is being updated to reflect appropriate revisions to the Use, Operation, Maintenance, and Management of Post Recreation Areas on Fort Leonard Wood (FLW).

Summary. This regulation establishes procedures and policies governing the use, operation, maintenance, and management of Installation Recreation Areas on FLW.

Applicability. This regulation applies to all personnel using FLW, Installation recreational facilities.

Proponent and Execution authority. The proponent agency of this regulation is the Directorate of Family and Morale, Welfare, and Recreation (DFMWR).

Supplementation. Supplementation of this regulation is prohibited unless specifically approved by Headquarters, United States Army Maneuver Support Center of Excellence (MSCOE) and FLW.

1. Purpose

To assign responsibilities and prescribe policies and procedures governing the use, operation, maintenance, and management of outdoor recreation areas on Fort Leonard Wood (FLW) and Lake of the Ozarks Recreation Area (LORA).

2. References and Forms

3. Explanation of Acronyms

The acronyms, abbreviations, and definitions used in this regulation are explained in the glossary.

4. General

- a. Eligibility- Designated parks and picnic areas (Colyer Park, Happy Hollow, hiking trails) are intended for use by all authorized Department of Defense (DoD) personnel including Civilians.
- b. Swimming is prohibited on FLW unless in established designated areas. Prohibited areas include Big Piney River and Happy Hollow.
- c. Required use of iSportsman-
 - (1) Similar to hunting/fishing/trapping, personnel desiring to conduct recreational activities on FLW (but outside the cantonment area) are required to conduct the safety briefing via iSportsman's website prior to issuance of any recreational permit (Note: Rules/requirements for hunting/fishing/trapping are contained in FLW Reg 210-21).
 - (2) Personnel recreating outdoors in maneuver/hunting areas of the FLW installation must obtain a Recreation Permit via the iSportsman's Website. The Recreation Permit is provided at no cost immediately after creating an account and taking the safety quiz. Each individual desiring to access an area for the purpose of recreation would be responsible for checking in and out of areas using the iSportsman's website.

 - (3) Outdoor recreation activities that would require a Recreation Permit (outside of the cantonment areas) include, but are not limited to; berry/mushroom picking, looking for shed antlers, cycling, hiking, and scouting for areas to hunt (also see FLW Regulation 210-21).
 - (4) Those persons possessing an iSportsman Permit (hunters, fishermen and trappers) are also required to obtain the Recreation Permit, at no cost.

(5) Personnel using only recreational facilities in the cantonment area such as Colyer Park, Outdoor Adventure Center (OAC), pools, or other sports/athletic facilities are NOT required to register with iSportsman.

(6) Additionally, although outside the cantonment area, patrons wishing to utilize Happy Hollow and LORA are also NOT required to register with iSportsman to use.

5. Responsibilities

a. DFMWR is responsible to validate all active permits for the following; disabled veterans with at least 60 percent disability, youth, and any individual 65 and older. Individuals will have to physically come to the OAC with proper documentation prior to issuance of validation.

b. DPW is responsible for grass mowing in areas accessible to motorized equipment, maintaining, and repairing installed property, grounds, buildings, and utility service.

c. DPTMS (Range Operations) is responsible for announcing areas open for recreation, hunting, and fishing. The Privately Owned Weapons (POW) Range (range 1) is a recreational shooting range. The range is run by DPTMS, Range Operations.

d. FLW Post Detail is responsible for routine policing, raking, grass mowing, and trimming in recreational areas not accessible to DPW equipment. These areas include Happy Hollow and Colyer Park in accordance with the installation police policies.

e. Users are responsible for ensuring that all protocols outlined within this regulation are upheld at all times. Failure to uphold these regulations could result in fines and/or restrictions.

6. Recreation Areas

a. Colyer Park, with the exception of special holiday or major unit organization day activities, will generally be on a first-come, first-served basis. Large groups or organizations may reserve the north and south pavilion and other areas by contacting the OAC.

b. Happy Hollow and the pavilion park area can be reserved by contacting the OAC. The area is off limits between 2100-0500 unless an approved function has been coordinated through OAC. Fishing is open to anglers remaining within 50 feet of the shoreline in lieu of those reserving Happy Hollow. No swimming is authorized at Happy Hollow.

c. The East Gate Area is only open for special-use events approved by the Garrison Commander (i.e. Boy/Girl Scout events, etc). Outside of these special events, East Gate Area is off limits to any overnight camping – to include tents, Recreational Vehicles (RVs), travel trailers or vehicles. See the OAC to begin the process of requesting use of the East Gate area.

d. The privately owned weapon range (range 1) is located off of FLW 30. All firearms that are used on this range must be registered on FLW. Users must sign on and off the range at Range Operations.

e. Bloodland Lake is located off of Airport Road (Arkansas Avenue) and is a primary recreation area on FLW. Check in via iSportsman is required to utilize this area.

f. Training areas that are closed to the population will be reflected under the iSportsman website
