### Key Elements of WSMR's Environmental Policy

- Support the Mission
- Comply with laws and regulations
- Practice Pollution Prevention
- Minimize environmental impacts through continual improvement



## What is EMS?

- EMS is a tool that helps us establish and achieve environmental protection goals
- EMS helps us control the environmental impacts of our day-to-day activities
- EMS helps us comply with current environmental requirements and manage future issues
- EMS helps us improve our environmental performance

#### 2. How is WSMR's Environmental Policy implemented?

- The Policy is implemented through the EMS and Unit Environmental Officers
- You implement the policy through your daily business practices

#### 3. How can you help implement the Environmental Policy at WSMR?

- Immediately clean up oil spills with absorbent
- Shake "empty" toner cartridges and put them back in for longer use before replacing, then recycle cartridges
- Avoid idling vehicles or running equipment needlessly
- Turn off lights and equipment when not in use and at night
- Purchase recyclable products made with recycled materials
- Reuse products as appropriate
- Recycle what you can

#### 4. How do you manage and/or control your impact on the environment?

- Follow procedures, i.e. Standard Operating Procedures (SOPs), maintenance requirements, etc.

#### 5. Where do you find SOPs and other procedures?

- Check with your supervisor
- Check next to equipment
- Check on bulletin boards
- Check in office/shop files or library



#### 6. What happens when you follow the procedures?

- The job gets done in a timely manner
- You only have to do the work once
- You minimize impacts to the environment

#### 7. What if you see changes that should be made while performing your daily duties that will improve your operations and protect the environment?

- Use your supervisory channels
